\_\_\_\_\_ I understand that lessons must be paid for in advance and that all fees are non-refundable.

\_\_\_\_\_ I accept that registration is being held on a first-come-first-serve basis and that classes sizes will be limited to account for all social distancing recommendations by the Washington State Department of Health and the CDC. I understand that because of this, dancers are *only allowed to attend classes for which they have registered and to which they have been accepted.*

\_\_\_\_\_ Due to severity of the 2020 Coronavirus pandemic, My family and I agree to follow *all posted regulations with regard to social distancing measures* upon arrival and until exit from the International Ballet Academy campus. I understand that those who cannot or will not follow the strict regulations in place at IBA will not be allowed to continue in-person lessons at IBA. I accept that, if dismissed due to non-compliance, no refunds or credits will be given for tuition and fees paid.

\_\_\_\_\_ My family & I agree to abide by the International Ballet Academy Parent & Student Manual. \_\_\_\_\_ I understand the attendance will not be tracked and is the responsibility of the dancer during the IBA summer program and that make-up lessons for classes missed will **not be available and/or provided**. Credits and refunds for missed lessons will not be provided. I accept that only partial refunds or credits will be considered for missed lesson time during the IBA summer program in a case of serious injury with a formal written request and a physician's note.

\_\_\_\_\_ I understand and will abide by the IBA dress code in studio AND ONLINE. During the IBA summer program, leotard color is the choice of the dancer; however, all dancers must wear regulation dance shoes and tights, as well as the regulation style leotard. Dancers must ALL have their hair pulled back and out of their face. A ballet bun is REQUIRED for all ballet lessons, in studio and ONLINE.

\_\_\_\_\_ I understand and accept the IBA schedules and that these schedules are subject to change in the event it becomes necessary for the good of all dancers and the whole program, especially due to current events..

\_\_\_\_\_ I (and my student) understand(s) our own personal responsibility for our own personal property.

\_\_\_\_\_ I (and my student) understand(s) that all dancers must have video on when attending online lessons. I accept that dancers who are not participating in the online lesson, playing with equipment during the lesson, changing displays/names and/or chatting, or generally being disruptive, etc, will be removed from the online lesson without a refund. Remember, all of the same respect for the instructor that is expected during an in studio lesson at IBA is expected of our dancers using the online method of learning.

International Ballet Academy and its faculty shall not be held responsible for any injuries that occur while taking part in any programs at IBA or during an online lesson with IBA, to include family members of students in attendance either in person or online.
